FAQs

As a child welfare worker or supervisor, how many in-service training hours do I need to complete? All public and private child welfare staff are required to complete 32 hours of in-service training each calendar year (January through December). This includes caseload carrying and other child welfare staff with specialized and supportive positions to CPS, foster care, and adoption. Additionally, child welfare supervisors are required to obtain 16 hours of in-service training each fiscal year.

2 How do I record these in-service training hours to show that I am meeting this requirement? Add the training to the Michigan Department of Health and Human Services (MDHHS) Learning Management System (LMS) as external training. Your supervisor will receive an email to approve it to be added to your transcript.

I see that each training in this catalog has a curriculum reference. What does this mean? Child welfare and family preservation workers have the opportunity to attend training each year that is based upon a curriculum developed in partnership with the MDHHS Office of Workforce Development and Training and the workforce. Workers should have the opportunity to sit down with their supervisors regularly to assess which trainings would be most beneficial and most relevant to their caseloads so that training progress is pre-planned and helps each worker advance professionally. The LMS website includes a tool called "Create Employee Training Plan CWTI" that can assist with this effort.

Do I register to attend the training with the university that is hosting the training or through the MDHHS Learning Management System (LMS)? In order to register to attend a training, you should follow the registration instructions found in this catalog. In order to record your in-service training hours with the MDHHS Office of Workforce Development and Training, please follow the directions found in FAQ 2.

5 Is it true, I can attend any in-service training listed in this catalog for FREE?! Yes! The child welfare in-service trainings provided through this collaborative effort are FREE OF CHARGE for child welfare and family preservation workers and supervisors—both MDHHS and contracted private agencies—on a first come, first serve basis. These trainings are eligible for social work continuing education credit hours, too! Happy training!

- Access resources for reporting the suspected victims of human trafficking.

Description: Human trafficking is a worldwide problem that is widespread across all of the United States. Every year, thousands of women, men, and children are trafficked. People can become victims regardless of age, race, gender, or nationality. It is also often misunderstood and misrepresented, allowing trafficking to take place often right under our noses. Education about the realities of human trafficking—and busting the myths surrounding this topic—is a crucial step in fighting to make our country safer for the most vulnerable within our community. This training will provide skills and resources to better equip individuals to recognize and be a resource for people at risk of—or who are already—being trafficked in your area. - Identify practical ways that CRM can be embedded within the community to build community resiliency.

Description: The Community Resiliency Model® (CRM) is a biologically-based trauma intervention designed for community members who need information about trauma and coping skills but who have limited access to mental health resources. CRM teaches skills for self-care to balance the nervous system of those impacted by personal or community-level trauma such as violence, poverty, racism, and homophobia. Participants will receive tools they can immediately implement as well as learn about future events for gaining deeper understanding of the model. This training will utilize role playing, exercises, games, small and large group discussions, and visual displays.

State regulation begins with the nervous system and finding healthy ways to have a flexible nervous system that can meet the demands or challenges of life in the moment. As you work with clients, they will naturally become dysregulated at times as they become triggered with past experiences or need to work with current challenges. We will learn what is occurring in the nervous system and the body during these times and how you can work with clients prior to becoming dysregulated and during a dysregulated state. Description: This training will cover the traumatic impact the child welfare system has on children, youth, and families. The goal is to provide an understanding of how state governments think about the adequacy/appropriateness of parenting, the safety of children, when and how child protection agencies get involved with families, and what the evidence says about such involvement. The content will focus on the early phases of intervention, including barriers to engagement that may result from client—worker differences, involuntary participation on the part of the child, youth, or family, and factors external to the client—worker relationship such as policy or institutional decisions that may influence or shape intervention. Since work with children and youth almost always requires multiple intervention modalities, attention will be given to creating effective intervention plans through the integration of different modalities. Those intervention methods that have been empirically demonstrated to be effective will be given particular emphasis. Intervention strategies taught in this training rely significantly on the social worker as a critical component of the change process, thus attention will be paid to the understanding of self as an instrument in the change process. This training will utilize small and large group discussions and visual displays.

- Understand the implicit biases and micro-aggressions present without a conscious effort to minimize personal values and beliefs that are contrary to the values and beliefs of families served.
- Incorporate cultural humility practices when working with all families.

Description: This training will provide a better understanding of one's own personal values and beliefs and their relationship to cultural identity and practice. The training will begin with participants working to understand their own personal values and beliefs. In a large group, we will discuss personal values and beliefs, provide some examples, and then break into smaller groups for reflection and discussion. Participants will be asked to share their personal beliefs and values with the larger group at which point we will move into a discussion about the differences in personal values and beliefs and those values and beliefs professionals hold. This is where we will begin to discuss implicit biases and microaggressions. In the large group discussion, an overview of implicit biases and micro-aggressions will be presented as well as a discussion on how these can become present in our work without a conscious effort to minimize personal values and beliefs. We will then break into smaller groups for reflection and discussion as well as small group exercises related to recognizing implicit biases and micro-aggressions. Finally, we will come back into the larger group to incorporate discussions of cultural humility practices, defining cultural humility compared to cultural competence, and how as child welfare professionals we can work to incorporate cultural humility within our practice. This discussion will evolve into a discussion on raising consciousness in upholding professional values and beliefs while minimizing personal values and beliefs, particularly those that get in the way of competent work with families. We will break into smaller groups for reflection and discussion, along with final exercises that incorporate all three learning objectives: (1) identifying personal values and beliefs particularly when those values and beliefs differ from our clients; (2) identify ways implicit biases and micro-aggressions can be present in our work and how to build consciousness to combat those when working with families; and (3) commit to engaging not only in cultural competence but cultural humility when working with all families. This training will utilize exercises and small and large group discussions.

Based on research in Korea, China, Russia, Spain, Nepal, Vietnam, Ghana, and Tunisia, the webinar will introduce the conditions under which ISC_CM is associated with better outcomes for children and the conditions under which it is not. A particular focus is given to conditions in which ISC_CM is normative in Ghana and how that fact changes the potential for child protection. The webinar will suggest an alternative to the current model, in which protection cases are triaged differently, with "minor" cases of maltreatment reverted to designated accountable community leaders who coordinate and supervise protection of the child with the tools of informal social control and informal social support. The alternate approach would require extensive community education and relationship building with communities and between communities and the child protection system. This webinar will suggest child protection can improve services by looking to lessons learned in Vietnam, Ghana, Nepal, China, Korea, Russia, and Spain. Conflict often arises because of breakdowns in communication, expectations (both spoken and unspoken), and trust. While many might prefer avoiding conflict altogether, it only manages to "pop-up" in unexpected ways at later times. Left unaddressed, it can have a negative and lasting impact on both relationships and outcomes. This is especially true when having difficult conversations around race and power. Non-Violent Communication (NVC) uses a four-part guide as part of its conflict resolution philosophy that is used to address conflict in a productive and transparent way. This webinar will introduce you to the model of Non-Violent Communication, review the four-part process, and identify opportunities to practice its application as a method for conflict resolution. Connecting Brain and Behavior

This online course will focus on atypical brain development resulting from exposure to prenatal teratogens and/or prenatal and early childhood chronic trauma. Resulting behavioral, emotional, and social concerns will be explored. Common interventions will be discussed and evaluated through a neurobiological lens.

Dissociative Coping in Traumatized Children

This online course will review the underlying risks leading to dissociative coping in children. Children exposed to traumatic events frequently rely on dissociative strategies to manage intolerable fear or pain. Younger children, in particular, may be vulnerable as their skills of managing stress are limited. Dissociative tendencies are easily misinterpreted by caregivers and professionals as intentional or characterological (i.e., "ignoring me" or "lazy"). Implications for assessing and treating traumatized children will be included.

When Addiction Trumps Relationships: Working with Mothers and Addiction This online course will present information on the scope of the problem of mothers with substance use disorders and the impact of this problem on children. Common substances of abuse and their impact on biological and behavioral functioning will be discussed. You will learn the impact of addictive processes on the capacity for attachment among mothers with addiction and difficulties with emotion regulation and reward systems. A description of current practices with substance abusing mothers and their children will also be presented.
